I. THE STATUS OF THE CORE FUND

1. As of 31 December 2020, the balance of the NEASPEC Core Fund was US\$943,779. In 2021, contributions from China and the Republic of Korea were US\$44,985 and US\$254,079, respectively. The Government of Mongolia has expressed its commitment to contribute to the NEASPEC Core Fund annually starting from 2022. The Secretariat has received US\$4,982 from Mongolia to the Core Fund for the 2022 budget year.

2. As of 30 June 2022, the balance of the NEASPEC Core Fund was US\$955,702. Table 1 illustrates the details of the NEASPEC Core Fund as of 30 June 2022.

3. Tables 2 and 3 show the status of the project budget by programme area and budget category of expense for the project period of 2016-2020 and 2021-2025, respectively. As of 31 December 2020, the total project expense was US\$583,517 for the project period from July 2016 to December 2020. Due to the COVID-19 pandemic, all planned meetings in 2020 and 2021 were organized virtually, which resulted in substantial savings in travel and meeting-related costs.

4. For the budget period of 2021-2025, the budget was spent from January 2021 to June 2022 mainly for (1) project development and secretariat management and (2) activity implementation under each thematic work programme. The details of budget spending categorized by thematic work programme are as followings:

- (a) <u>Programme planning and management</u>: Project development and secretariat management, including salary for one international staff (50% of the post cost), one local staff, fees for consultants, and cost for development NEASPEC website (US\$227,162)
- (b) <u>Air Pollution</u>: two consultants for NEACAP policy analysis report and Best Available Techniques review paper respectively (US\$19,389)

- (c) <u>Marine Protected Areas</u>: (1) Translation (Japanese and Korean), layout and printing of the publications; and (2) NEAMPAN Workshop (15 July 2021, online) online facilitation via KUDO¹ including simultaneous interpretation (US\$29,488)
- (d) <u>Biodiversity and Nature Conservation</u>: All activities were conducted online which resulted in savings on travel and meeting costs. The project activities were implemented using separate Nature Conservation project funds. Please find more details in Table 7.
- (e) Low Carbon City Platform: (1) International Forum on Low Carbon Cities (23-24 November 2021, online) online facilitation via zoom with simultaneous interpretation, (2) Science, Technology and Innovation (STI) for Low Carbon and Resilient Cities: Training Workshop (16-17 December 2021, Hybrid form-online and Ulaanbaatar, Mongolia) consultants for simultaneous interpretation (Chinese-English and vice versa), and (3) Printing of the Comparative Study on Low Carbon City Development in China, Japan, and the Republic of Korea (US\$10,582)
- (f) <u>Desertification and Land Degradation</u>: One consultant for a stock-taking study on the interlinkage of Desertification and Land Degradation (US\$8,000)

5. The financial status of NEASPEC Fund categorized by the nature of expenditures is presented in Table 3 below. In the year 2021, the Secretariat spent US\$212,065 or 11.16% of the total budget, whereas the Secretariat has accumulatively utilized US\$294,622 or 15.51% of the total budget as of 30 June 2022.

6. The COVID-19 pandemic has continued to persist during the first half of 2022, and it has led to changes in the programme implementation modality from in-person meetings to virtual meetings. Therefore, the Secretariat requests the redeployment of budget lines to reflect the changes in the programme implementation modality.

7. Below is the proposed revised budget for consideration. The total budget for the period remains unchanged.

8. The saving from the "Travel" budget during 2021-2022 in the amount of US\$174,700 is proposed to be redeployed to the followings budget lines:

- (a) "Contractual Services" line in the amount of \$90,000 to cover the cost of NEASPEC website development (US\$19,860), website maintenance service of US\$3,500/year, interpretation and translation services, and printing of publications and reports;
- (b) "Operating Expenses" in the amount of US\$82,200 to accommodate the cost of engaging vendors to set up and manage online meeting platforms, the license fee for online meeting platforms, and video-recording; and
- (c) "Supplies and materials" in the amount of US\$ 2,500 to cover the cost of office supplies.

II. THE STATUS OF THE PROJECT-BASED FUND

9. In addition to the activities funded by the Core Fund, NEASPEC operates the projectbased fund with contributions from member States for specific activities.

Project on "Strengthening the subregional cooperation through knowledge sharing on sustainable management of Marine Protected Areas (MPAs)

10. Based on the agreement with the Government of the Russian Federation and pursuant to the decision of the SOM-21, the Secretariat implemented the project on "Strengthening the subregional cooperation through knowledge sharing on sustainable management of Marine Protected Areas (MPAs)". The contribution of \$120,000 was transferred from the Russian Federation in 2018. The project was approved for operation from 1 March 2018 to 30 June 2021. Upon closure of the project budget as of 8 December 2021, the total amount of expenditures was US\$78,500 (Table 5). The balance of US\$47,056, inclusive of interest income of US\$5,556, was transferred back to the ESCAP-Russian Funds in December 2021.

11. Due to the COVID-19 pandemic, a planned workshop could not take place. Upon the approval by the Government of the Russian Federation, the Secretariat thus changed the project activity plan and used the funds initially allocated for the workshop for translating the study outcomes into the languages of the NEAMPAN members (Chinese, Japanese, Korean and Russian). Key expenditures were made as follows:

- (a) Engagement of translation services of the project report into Chinese and Russian languages (The translation cost for Korean and Japanese languages were funded from NEASPEC Core Fund budget); and
- (b) Printing of the project report

Project on "Transboundary cooperation on the conservation of Amur tigers, Amur leopards and Snow leopards in North-East Asia"

12. The SOM-23 endorsed the project including three components; (1) transboundary cooperation between the Northeast Tiger and Leopard National Park (TLNP) of China and the Land of the Leopard National Park (LLNP) of the Russian Federation to conserve Amur tigers and leopards; (2) transboundary cooperation between neighboring protected areas in Lesser Khingan Mountains to conserve Amur tigers; and (3) the assessment of two snow leopard subpopulations in the transboundary areas between Mongolia and the Russian Federation, with the total contribution of US\$ 377,081 from the Russian Federation (Table 6). The project period was initially from January 2020 to September 2022, but the Government of the Russian Federation approved an extension by December 2022 to complete all planned activities.

13. The major activities in 2020-2022 with key expenditures up to the date of the report include the following:

- (a) On project component 1: "Transboundary cooperation between the Northeast Tiger and Leopard National Park (TLNP) of China and the Land of the Leopard National Park (LLNP) of the Russian Federation to conserve Amur tigers and leopards": Out of the contract amount of US\$96,000 for the LOA with LLNP, US\$30,000 was advanced to LLNP for initial project implementation activities in early 2022. The remaining amount of the contract is pending for payment.
- (b) On project component 2: "Sino-Russian transboundary protected areas and feasibility study in Lesser Khingan Mountains to conserve Amur tigers": The committed contract amount of US\$50,000 for the LOA with the WWF Russia (Amur branch) and the Feline Research Center has been released (US\$25,000, respectively).
- (c) On project component 3: "Assessment of the current status of two snow leopard subpopulations in Transboundary are between Mongolia and the Russian Federation": The committed contract amount of US\$50,000 for the LOA with the Irbis Mongolia Center and the WWF Russia (Altai-Sayan branch) has been released (US\$25,000, respectively).

III. IN-KIND CONTRIBUTIONS FROM PARTNERS AND OTHERS

14. During the past budget period, the Secretariat obtained additional financial and inkind support from project partners through joint activities or collaboration. Table 8 details inkind contributions that the Secretariat received in 2020-2021. In addition to the activities listed in the table, the Secretariat has collaborated with various project partners in member States for project implementation. Those partners include but are not limited to, Baikal Institute of Nature Management of the Siberian Branch of the Russian Academy of Science (BINM SB RAS), Climate Change Research and Cooperation Centre (CCRCC) of Mongolia, Green Climate Fund (GCF), Innovative Green Development Program (iGDP), ICLEI East Asia Secretariat, Incheon Climate and Environment Research Center, Incheon Metropolitan City, Korea Marine Environment Management Corporation (KOEM), and OJEong Resilience Institute (OJERI) of Korea University.
